How do I donate?

The Distillers' Charity is divided into two distinct funds, which each support our charitable giving. Both of these funds depend upon the generosity of the Livery and there is an expectation that members will support our charity:

- Distillers' Charity Annual Fund. Funded by regular donations from Liverymen, the full value raised for the Distillers' Annual Fund is available to be allocated to grant-making each year. These contributions by Liverymen are available for immediate charitable use.
- Distillers' Charity Endowment. The Distillers' Charity Endowment has been funded over the years via periodic fundraising initiatives, including charity auctions, legacy appeals, one-off donations and other campaigns. Funds are drawn down from the Endowment to supplement our annual giving.
